

# SASKATOON CO-OP® “TOOL TREE GIVE AWAY” CONTEST

## OFFICIAL CONTEST RULES & REGULATIONS

The Tool Tree Give Away contest (the “**Contest**”) is sponsored by Saskatoon Co-operatives Limited. (the “**Sponsor**”). The Contest begins 12:00:01 AM CT on Saturday, November 12, 2023 (the “**Contest Start Date**”) and ends 12:01 AM CT on Saturday, December 17, 2023 (the “**Contest Closing Date**”), known as the “**Contest Period**”.

### 1. HOW TO ENTER:

NO PURCHASE NECESSARY. A purchase will not increase your chance of winning.

**Option 1:** Obtain one (1) Official Entry Form from any cashier or authorized personnel at a Participating Location with the purchase of every \$100 in DeWalt products (Avenue C Home Centre Location) or \$100 in Milwaukee Tools products (8<sup>th</sup> Street Home Centre location). Return form to cashier or authorized personnel at participating location.

**Option 2:** Send an email to [MARKETING@SASKATOONCOOP.CA](mailto:MARKETING@SASKATOONCOOP.CA) with your full name, address, email, and phone number with the subject line: Holiday Tool Tree (choice between Milwaukee or DeWalt).

All entries must be received on or before the Contest Closing Date.

### 2. ELIGIBILITY:

#### Eligible

To enter the Contest and be eligible to win a prize in the Contest, a person must be a resident of Saskatchewan, and the age of majority in the jurisdiction in which he or she resides as of the Contest Start Date.

#### Not Eligible

The Sponsor’s employees and the Sponsor’s Board of Director as well as the immediate family\* and those domiciled with the Sponsor’s employees and Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

Employees of the Sponsor's and the Co-ops' operators, affiliates, agents, independent judging organization, consulting, advertising and promotional agencies, as well as those domiciled with and the immediate family\* of the foregoing, are not eligible to participate in the Contest or win prizes in the Contest.

\* "Immediate family" includes parents, siblings, children and spouses.

### **3. PRIZES:**

Two (2) holiday tree prize packs valued at approximately \$500 each.

Prizes must be accepted as awarded. Prizes may not be sold, converted to cash, are non-transferable, and no substitutions are permitted. One prize per winning entry; one prize per household. The Sponsor reserves the right, in the event that a prize or any component of a prize cannot be awarded as described for any reason, to substitute another prize of equal or greater value without liability.

The chances of being selected are dependent upon the total number of eligible entries received during the Contest Period.

### **4. PRIZE WINNER:**

A random draw will be made on Monday, December 19, 2023 in Saskatoon, Saskatchewan from among all eligible entries received on or before the Contest Closing Date. Selected entrants will be contacted by telephone or email within seven days of the draw date. If a selected entrant cannot be contacted within seven days of the draw date his/her entry will be disqualified and another entrant will be randomly selected. To be declared a prize winner (the "Prize Winner"), the selected entrant must: (1) correctly answer a mathematical skill testing question to be administered via telephone, mail or email; and (2) complete, sign and return a Statement of Compliance, Release and Indemnity Agreement to the Sponsor within 14 days of receipt of written prize notification or prize will be forfeited and an alternate Prize Winner selected. Prize Winners consent to the use of their name, address (city and province) and photograph without compensation, in any future publicity carried out by the Sponsor.

### **5. GENERAL:**

By entering the Contest, entrants agree to abide by these Official Rules and the decisions of the Sponsor with respect to all aspects of the Contest, which are final. This Contest is subject to all applicable federal, provincial and municipal laws. All entries become the property of the Sponsor and none will be returned. By entering this Contest, entrants consent to the use of their name and address (city and province) by the Sponsor for the purposes stated herein.

The Sponsor reserves the right to disqualify any entrant in the event of fraudulent Contest entry or other violation of these Official Rules. Entry forms are subject to verification and void if obtained illegitimately, or if altered, mutilated, forged, tampered with or irregular in any way.

Subject to applicable law, the Sponsor reserves the right, in its sole discretion and for any reason, to cancel, terminate, modify these Official Rules or administration of the Contest or suspend this Contest in whole or in part without prior notice and with no obligation or liability. In the Sponsor's sole discretion, a Prize Winner may be selected by randomly drawing from among all valid entries received up to the time of cancellation, termination or suspension.

By participating in the Contest, entrants agree to release and indemnify the Sponsor and any independent judging organization as well as their respective parents, affiliates, member retail co-operatives, agents and contractors, including advertising and promotional agencies, and their directors, officers and employees, from any and all losses, expenses (including legal fees), damages and claims of any kind in connection with the Contest or resulting from the acceptance, possession or use of any prize, including without limitation any loss, personal injury, death, property damage, or claims based on publicity rights, defamation or invasion of privacy.

Under no circumstances will the Sponsor, its member retail co-operatives, subsidiaries, affiliates, independent contractors, and their respective directors, officers, employees, and agents, including advertising and promotional agencies, be responsible for any injuries, loss or damages of any kind (compensatory, direct, incidental, indirect, consequential or otherwise) with respect to or in any way arising from, this Contest or the prize awarded. In no event shall the Sponsor be required to award more prizes than what is indicated in these Official Rules or award the prizes otherwise than in accordance with these Official Rules.

## **6. PRIVACY:**

The Sponsor, Saskatoon Co-operatives Limited, respects your right to privacy. Personal information collected is not sold, rented or loaned to any third parties.

The Sponsor will use the information collected solely to administer the Contest. No correspondence will be entered into except with selected entrants.
